

Porcelain Conditioner FOR BONDING TO PORCELAIN CROWNS & JACKETS

Intended Use: Reliance Porcelain Conditioner is intended for use in the preparation of glazed dental porcelain for bonding.

Porcelain Conditioner is a silane coupling agent which chemically unites with the silicon in the porcelain and the acrylic in chemical, light cure and dual cure adhesives.

Instructions for Use:

- 1. Dispense one drop of Porcelain Conditioner to a mixing well.
- 2. Sandblast or roughen the porcelain surface with a fine diamond bur. Rinse and dry.
- If using Assure Plus, proceed to step 4. If Assure Plus is not utilized, the porcelain must be conditioned with Porc-Etch first.
- 4. Using an applicator, apply one <u>THIN</u> coat of Reliance Porcelain Conditioner. Wait a minimum of 3-4 minutes. Lightly dry with air for 20 seconds. If warm air is utilized to dry, the wait time can be reduced to 1 minute. NOTE: A NEW APPLICATOR IS REQUIRED FOR EACH PATIENT


- 5. Apply 1 coat of Assure Plus, lightly dry with air and light cure for 10 seconds.
- 6. Place any light cure, dual cure or chemical cure paste on the bracket base and position on the tooth. If a light cure or a dual cure paste is used, position light and cure per manufacturers' instructions.

If Rely-a-Bond[®] (no mix, chemical cure) is used, place a <u>thin</u> coat of Rely-a-Bond[®] Primer on the bracket base and the conditioned porcelain surface. Apply the Rely-a-Bond[®] Paste to the bracket base, position on the tooth, and press firmly.

If Phase II® or Excel® are used, apply mixed paste to bracket and seat.

PRECAUTIONS: May cause skin sensation in susceptible persons. In case of contact with the skin, wash thoroughly with soap and water. Contact with other tissues: rinse area immediately with copious amounts of water for several minutes.
